- RG-UG coordinator suggests that we remain mindful of the curriculum bringing back holes like Music for Dancers, someone can cover the courses that we have, and bring new cutting edge curricular interests to augment the curriculum. Connected to the curricular needs. Interested in working as a choreographer for our students. Musical Theater interests,
- DC-In crafting the job description-honing in on the specialist, meeting what the department needs- "we need a dancer who can teach dancing to our students." Stating in the job description pedagogical interest in modern historical dance forms. Mixes teaching and research while remaining present in the department. Gender diversity.
- MP-Hire a "hire a technique beast." Comes from a vibrant performing career, work situated in one of the historical forms. Leaning towards Limon; someone who could bring historical works. Someone who understands the Ballet progression. Someone who will teach across the curriculum at all level of training.
- B.J.-Someone who wants to be in the studio; interested in other ways of working with bodies a solo class, partnering.

2. 11:30-12:30: Compliance assist rubrics review; final data is due at the end of the September. Robin implement a process for the faculty to input data on an Excel sheet. The faculty updated BA and BFA undergraduate Compliance Assist rubrics.

3. 1:30-3:00: The faculty discussed annual review creative, academic and dance education research benchmarking. We broke up into the following discipline specific groups: Mila/Melinda, Jill/Ana Paula, B.J./Duane/Robin. Each group will submit their drafts to Janet for inclusion.

- Academic Scholarship: proposes satisfying accomplishments from column 1 and 2 for example in Column 1: Peer review article in a journal; proceedings; the completion of a chapter for a manuscript. Column 2 includes: Organizing a panel; serving on an editorial board
- Creative Scholarship 4 points--Taking into account: 1. Time spent, for example 15 hours a week. 2. Outcomes-workshops, films or visual work, directing, virtual work, creative presence at conferences or festivals. 3. Process or Method--Invited or commissioned, ongoing or one-time. 4. Positioning in the field, i.e. impact—advancing a theory or idea or experimental. Research workload discussions could take into the rank each individual faculty member.
- Dance Education—Including curricula development and distribution, pedagogical film or DVDs, Self-Produced research, requested chapters and proceedings, web-based publication, presentations and performances, commissions (move to creative scholarship)

4. 3:20-3:50: Discussion of dance history/studies course content, competencies and course progression discussion. Janet suggested swapping the progression of content to begin with modern and postmodern course as DCE 205 Dance History I: Modern and Post-modern dance as a first year spring course. In the junior year fall semester, students would enroll in DCE 306 Dance History II: Dance in/as Culture. Janet can submit Routine Course changes at the top of 2016-2017 academic year to take effect in Spring 2017.

Conversations also took place amongst the faculty as how we might integrate organized historical activities into DCE 117 for example, Duane could come into share Ailey content.

At this point alumna Alex Warrant will be choreographing for the 143 students in the Fall, Roger Jefferies for 243/343 the Spring, DCE 443/487 will dance Graham's *Prelude to Action* and we are hoping to invite Masha Dashkina (currently in Winston) in to teach a week of Graham classes across the Contemporary area. Finally, Gerri Houilian is on board to teach DCE 412 for 4 Fridays in the fall term.

Event Request Information: Deadline: April 22 for submission to Janet and Chris. All requests have been reviewed and entered in the Department Calendar. Guidelines for production dates and support are provided below:

a. Requested dates with at least one possible backup. In selecting dates try to avoid back-to-back production weeks with another event in the same performance space, along with proposals to present in the same week

as another event is in production. Also please avoid the Bill T. Jones/Arnie Zane UPAS production scheduled in February 2017.

b. Number of performances, and any special production needs or requests, including set building or live-streaming requests.

c. Will your event require a full production week (usually Sunday through opening night), and will you need a full crew?

d. Will you be selling tickets? We use Triad Stage Box Office. They charge a \$1.00 per ticket fee back to box office earnings. Please see the Dance Faculty Handbook to see more guidelines under other concerts by faculty if you are proposing a concert not directly linked to a dance course.

e. Will your event address the War and Peace Imagined theme?

Additional note:

Effective Fall 2016 term—322, 208 and 306 cannot support environmental production elements such as dirt, sand, baby powder etc. Water within limits has proven to be workable, but since these spaces are also teaching spaces the items mentioned above are too disruptive for production and house keeping. If choreographers have questions about acceptable usage please contact Janet and Chris.

Other questions:

a. The faculty had questions about how live streaming is working. Currently, Live Streaming is available when we can "piggy-back" on the Music's technology. There is only access in 306 for Live Streaming. Amy will make requests early in the fall term for possible Live Streaming dates in the 2016-2017 production season.

b. The faculty notes that the structure of *The Evening with the Creative Class* event has a lot of faculty collaboration possibilities.

2. Compliance Assist (Weave), BA 5, BFA 7, MFA 4 SLOs

Discussion: B.J recommended that we establish rubrics to use across the curriculum. Robin suggested using the MSTR process and other existing assessment activities.

Robin has sent out the Google doc that showing the SLOS/metrics, for courses requiring Compliance Assistant, and graduating seniors for which we need responses for reporting. Robin suggested that we streamline the metrics down to 3-4, and separate BA and BFA outcomes, and working to align particular course assignments to the metrics.

We will touch base on these topics again at the term-end meeting, as well as throughout the year, and review the SLOs annually. For example, how do we integrate the technology component? The faculty suggested that we have implementation process to input data on an Excel sheet or other technology.

1. Dance Budget 101-budget-overview of funding sources, and budgets in the School and the Dean's office.

There are several types of budgets that affect Dance operations. All personnel monies are managed by the SMTD Dean's office. The Dean's office informs the Dance Department Head if there are merit or compression/equity raises available. The Dean allocates TSR (Temporary Salary Reserve) monies to cover part-time instruction in the department. These funds are very limited, due to the current policy of vacant lines reverting to the Provost's office.

The Dean's office makes research funds available to faculty when available from his endowment funds. The Dean's office also makes allocations from

specific donor funds to support community engagement activities such as the Dancers' Connect program.

The Department has an OTP (Other Than Personnel) budget that comes from the state. These funds must be used each fiscal year—July 1-June 30. The Department Head and Business Coordinator manage OTP funds to pay for travel, guest honorariums, and other department operational activity.

Department Trust Funds roll over year-to-year. These funds, such as Box Office, are used to support production and curricular activities in the department. Box Office/Production funds are also used to pay for guest artists/choreographers, and ACDA attendance. An Discretionary Fund is currently populated by monies earned through the NDEO Online Professional Development partnership. This fund supports activities such as receptions and donor building activities.

Dance faculty received the 2016-2017 Budget request document for review and suggestions in February. Highlights of this year's request include: Waegerle appointment increase from 75% to 100%, grad stipend increases to keep us more competitive with other institutions, musicians for live accompaniment, guest artists, and Dance Medicine support.

The faculty will review the criteria for Department Trust funds at an upcoming meeting. They also support strategizing how we can increase accompanist and dance medicine support.

Kelly Burke addressed questions from the faculty about the FAR form process. The first question addressed the necessity of submitting the Delaware Outside of Classroom reporting form. Burke anticipates that this form will not need to be submitted again this year, but recommends that faculty track these activities for other reporting purposes.

FAR is a reporting tool related to workload, followed by a reporting mechanism for reporting activities beyond the assigned and approved workload. The Dance department will add a signature line to the 2016-2017 workload form, and consider identifying discipline specific benchmarks for research and scholarship. We can start by asking ourselves questions such as: What standards of productivity look like in are areas of expertise? How do we evaluate the merits of local and national credits? How do technique faculty account for the amount of time required to maintain a level of training necessary to teach technique classes? What are creative/scholarly practices in dance? Examples:

- 1. Editing a book, curating a film or dance festival event
- 2. Published article, choreographic or performance premiere

Associate Dean Burke, encouraged the Dance Faculty to think of Peer Review as a mentoring process that supports positive professional interactions. She also stated that she would welcome the opportunity to address faculty questions on the workload or P&T process in individual meetings.
