Teaching Statement

Moses distributed the Course GPA Statistics by Year and type of Class. John Ceneviva made a motion to accept the Teaching statement as revised. Seconded by Bill Tuller. The Teaching Statement was unanimously approved with an amendment to the course GPA requirement.

The item #2 for the evaluation criteria was amended as follows “The instructor demonstrates excellent academic standards as evidenced by the average GPA which should not exceed the departmental average plus one standard deviation in the previous year by the type of class (CBK, UG Electives, MBA) in the course; and the quantity and quality of assignments and exams. If the course GPA deviates from the departmental mean GPA, the instructor is invited to write an explanation in the annual review 2-page report.

Annual Review

Sedona - Journal Articles need to be clearly marked "Counted in 20XX". Journal Articles are counted in the year Accepted, not the year Published, unless the year Accepted and Published are the same.

Faculty Search

A new line was approved on December 23rd in the area of International Business, Organizational Behavior and Strategy (not Human Resources), since we are planning to offer a Masters in International Business and PhD in Management. The search Committee members are Vas Taras, Chair, Bill Tullar and Tracy Liu.

Curriculum

Business Studies students can now do a Minor in Entrepreneurship and Marketing (Sales). However, they can only double count a maximum of two courses if they minor in Entrepreneurship and Marketing.

For students who minor in Entrepreneurship they can only double count the following courses – ENT 300 and ENT 336. All other Entrepreneurship courses they take cannot be counted towards the Business Studies degree.

For students who minor in Marketing they can only double count the following courses – MKT 324 and MKT 327. All other Marketing courses they take cannot be counted towards the Business Studies degree.
