- 0. Welcome and Introductions (2 Minutes), Attendance Robert introduced Deanna Miller from the Triad Goodwill Organization.
- 2. One minute Forum Robert Kantlehner/Ann Stringfield Ann Stringfield presented information on the economics of taking buildings down and replacing them with parking lots. This practice tends to be a poor economical decision in the long term. This is relevant as two churches in Fisher Park have plans to build parking lots close to the churches. Robert reported on an upcoming COA for new lights in the Aycock district. The neighborhood association wants upgrades to the new lights and the city wants the neighborhood to pay for the upgrades. This will be coming up at the meeting this week.
- 3. Reports from June Meeting 2011 (5 minutes)
  - Neighborhood Meeting Minutes were not available prior to the meeting but will be made available at the next meeting.
- 4. Deanna Miller Good Will Donation Program Deanna who is a marketing specialist for Goodwill industries in Greensboro, reported that Goodwill helps people who have a barrier to employment. She reported that Goodwill uses the donations for Goodwill to pay for their employment services to their clients. Deanna indicated that they would like a neighborhood contact person to generate at least 20 neighbors to receive a pick up bin that the neighbors could put out with items on scheduled pick up days. These bins will then be put at front doors and drivers will pick up the items in the bins. The donator will then receive a receipt that can be filled out for tax purposes.
