- 3. Reports from August Meeting 2011 (5 minutes)
  - Approval of minutes from previous meeting
  - Motion to approve minutes with correction to Daintry O'Brien's last name- approved

  - 1. #1441 836 Olive Street Construction of deck on the side of the house; setback recommendation; two close to the street so need special exemption, 14 x 16 deck made from wood.

Move to support the COA as is - motion approved

- 2. #1452 108 Fisher park Circle Tree removal (after the fact) support enforcing the current rules regarding tree removal.
- #1455 206 Fisher Park Circle Construction of garage match brick of garage to brick of house, windows will be simulated divided light.
   Move to support this COA as is- motion approved
- 4. #1454 230 South Park Drive Repaying of driveway and parking area, removal of tree would like to save the tree if possible, pavement is over the roots of tree;

  Move to approve the paving project with modification of trying to preserve the trees if at all possible motion approved.
- 5. #1457 302 Isabel Street Construction of addition to the house will use the same materials on roof and use the same brick on back of house

  Move to support COA as is motion approved

Robert reported that if windows and doors are at least 50 years old then they are considered "original" and will follow guidelines. This was a discussion at the August meeting.

Move to allow the expenditure of up to \$400.00 for this event - motion approved

- Streets and Sidewalks Greg Grieve is trying to get the Neighborhood Small Projects Grant to pay for the repair of fisher Park Neighborhood street signs. He is working on getting an exact price quote of the work needed in order to include in the grant.
- 7. Luminaria discussion Rob Pope will host the kit assembly event again this year; ask Rob about current cost of each luminary kit so neighbors can be told how much the neighborhood gets for each kit. The hope is that this will encourage neighbors to make a donation to FPNA. It was also discussed that there is a need for neighbors to host open houses for this annual event. Robert Kantlehner offered to host an open house.
- 8. Flashing light for pedestrian crossing on Elm Robert reported on the efforts of trying to make it safer to cross Elm Street prior to the two pedestrian crossings. Robert will email John to let him know we support this project which includes flashing lights prior to the pedestrian crossing.
- 9. FPNA to fund 3 or more \$100 Tree for Greensboro Memorial Trees through Greensboro Beautiful to be planted along greenway at Fisher Avenue in memory of Mike Ali of Red Mike's.
- 10. Robert reported that condominiums are scheduled to be built at the old North State Chevy property. It was recommended that we invite the group building the condos to come talk to FPNA board about the plans.
